GFCO LICENSING APPLICATION

AGREEMENT

The Company and GFCO agree to be bound by the following terms and conditions (the "Agreement"):

1. The Gluten Intolerance Group owns the GFCO Certification Mark (also known as the GFCO Logo), the current version of which is set forth in the GFCO Branding Standards. The current version of the Branding Standards, and any subsequent updates given with 30 days notice, are incorporated as part of this Agreement. Subject to prior approval by GFCO, GFCO hereby grants Company a limited, worldwide, nonexclusive, non-transferable, non-sublicensable, non-assignable, revocable, royalty-free license to use the Certification Mark on products appearing on a valid GFCO certificate that are made only at Manufacturer's plants named above. Company may use the Certification Mark (i) on Product Labels, and (ii) in online, digital, and print advertisements and promotional materials, including point-of-sale displays, directly related to the Products (collectively, "Promotional Materials"). No other right, title, or license is granted under this Agreement. The Certification Mark may not be used with respect to any non-certified products.
2. The certification mark may not be used in any way that might indicate that GFCO has certified other products, the Company itself, or any personnel. The Company may not make any misleading statements regarding certification or certified products, may not use Product certification in such a way as to bring GFCO or the Gluten Intolerance Group into disrepute, and may only issue complete copies of the Product certificate to third parties.
3. The quoted fee must be paid annually for the use of this license at the named Manufacturer's plants. Annual invoices may include price increases. These fees will not be pro-rated for any early termination of this Agreement. Additional licenses will be incorporated into your current billing cycle.
4. Company will respond to any and all communications from GFCO, given with due notice regarding changes in licensing criteria. Company is responsible for providing GFCO with current and updated contact information.
5. This License will automatically terminate in the event that Manufacturer ceases to hold a Product certification contract with GFCO. The initial term of this Agreement is one year, beginning on the issuance date of the initial GFCO certificate, which names the certified Products and Plants where they can be manufactured, and renewing automatically on the anniversary of that date (the "Renewal Date"). Any party (Manufacturer, Company or GFCO) can stop the renewal by providing the other party written notice of its intent not to renew at least thirty (30) days before the Renewal Date.
6. Company represents and warrants to GFCO that Company holds or has been licensed all rights, title and/or interest necessary to market, distribute and sell the Products, including the right to display any brand names or marks that may appear on the Product packaging.
